The ultimate CMO headhunter list was first released in April 2023 at a time more and more marketers were between jobs. Since then it has helped many marketers network with headhunters, secure roles, and unexpectedly, help create a career management model.

The original report has however become out of date as headhunter's change roles and their firms become more or less active. Headhunter remuneration can be biased to placement commissions, so in a tough market they can move as much as CMOs do. This new version is an up to date and more comprehensive list of C-suite headhunters produced during Q1 2024. My initial re-assessment was supported in detail by Kim Faura and John Woods, and subsequently run past a panel of CMOs including Simon Michaelis, Dawn Spencer, Andrew Geoghegan, Abigail Comber and Vikaas Saxena.

The new list is broken into 4 sections, with the new forth section of headhunters reflecting how some marketing roles are biasing into product and tech:

- Group 1: The biggest, most well-known headhunters who have the most CMO roles
- Group 2: The well-known boutique headhunters, who have some roles
- Group 3: The least well-known or smaller boutiques, with intermittent roles
- Group 4: The headhunters biased more to product and tech

The new list has the number of employees in each business to give a sense of scale, there is also a reference to candidate vs client engagement, a brief summary of their services (from their websites) and a comment from the panel on overall interactivity.

The candidate vs client engagement column reflects the response many candidates feel from their interaction with the different businesses, with the smaller boutiques often fostering far stronger candidate relationships than the big firms. There are practical reasons for this, and it is worth reading on to understand how to optimise your approach.

So how should you use this list?

Chances are you are looking at this list because you are between roles or looking to make a switch. The list will be helpful to you, but don't treat this moment as a one-off event. Investing time now into building a network and nurturing these connections is important for the long term. You have a career ahead of you, which you'll have some control over, but not as much as you may hope. CMOs still have the lowest tenure¹ in the C-suite and on average senior marketers will be exited 3 times² when they aren't expecting it. Investing time and energy in having a large, warm network helps give you more control, so you'll not only hear about exciting roles as they come up, but also have a network to kick into action when you need it.

This network ideally needs to be at least 50 headhunters. Of course some of these relationships will be far closer, and I still highly value relationships which started over 30 years ago, but finding a job is like fishing and the more fishing lines you have out the more chances you have. These 'lines' need to be sharp, distinctive and stand-out from everyone else. You are a brand, so you need to think like Byron Sharp³.







This does not mean bombing everyone on these lists with a long email, cover letter and CV. You need to think strategically and methodically:

- 1. Look at the list of companies and start to follow the ones you think are most relevant to you, so you get to understand what sort of projects they are working on and start to gather information to create conversation points in the future.
- 2. Get yourself fully prepared to engage. This means being very clear on your skills, your career story and what role you are seeking. You need to be memorable and clear don't be an OTA ('Open to anything').
- 3. Make sure your CV and LinkedIn profile is up to date and precise, and then make contact via LinkedIn or email with three simple paragraphs: who you are, what you are looking for, and suggest a quick chat. No long prose.
- 4. Target more junior consultants, associates and researchers at the larger firms and the partners at the boutiques. Partners in the larger firms will be focused on business development and won't have time for you.
- 5. Don't expect a face to face meeting. Many won't respond and a short 20-30 min video conference call is most common, so you need to be precise and unforgettable.
- 6. Stay in touch by being helpful, not desperate. This means connecting every 3 months with interesting information that is relevant to them and allows you to informally keeps them abreast of your plans. Always help them if they need advice on a brief!

These 6 steps of reaching out effectively to headhunters, plus the headhunter list, is part of wider career management and job-hunting model developed after a year of conversations with headhunters, outplacement firms and 'in-between' candidates.
